

International Football Association Board.

Minutes of Annual Meeting,

HELD AT

SLIEVE DONARD HOTEL, NEWCASTLE, Co. DOWN,
9th JUNE, 1928.

LAWS OF THE GAME

PROPOSALS BY THE SCOTTISH F. A.

Proposals regarding Laws 1, 8, 9, 17, etc., re Penalty Kick were, after discussion, withdrawn.

PROPOSAL BY THE FOOTBALL ASSOCIATION.

Law 1—Insert as Footnote (a) —“An International Match is deemed to be a Match played under the Rules of a Competition.”—Reaffirmed.

(This proposal is made in order to regularise an opinion expressed by the International Board at its last Meeting, the proposal not having previously been submitted to the National Associations, as required by the Rules of the Board).

The F.I.F.A., who took exception to the Footnote having been passed at the last meeting of the Board, to be informed that the decision is now reaffirmed.

An offer of a Trophy for Competition in International Matches was not entertained.

After discussion regarding the relations between the International Football Association Board and the F.I.F.A. the Conference was adjourned and the Chairman was empowered to convene same if necessary.

A vote of thanks was unanimously accorded to the Chairman.
