

I. CHAIRMAN'S REMARKS

Dr. Havelange extended a warm welcome to all the delegates, and in particular to Sir Stanley Rous, FIFA Honorary President, wishing them a pleasant stay in Mexico and an enjoyable World Cup.

The FIFA President explained that the meeting celebrated the 100th Anniversary of the first meeting of the International Football Association Board. He added that this anniversary demonstrated the importance of this one hundred year old institution and its excellent work so far accomplished.

The FIFA President pointed out once more the tendency of some National Associations to try and pass over the head of the International F.A. Board in order to introduce certain practices which contravene the Laws of the Game for the sole purpose of favouring their teams which are under pressure by their national team coaches. Dr. Havelange gave his assurance that FIFA would not permit the Laws of the Game – authorised by the International F.A. Board and published by FIFA – to be altered or amended without the consent and approval of the Board. He added that what is more FIFA would take all measures necessary to prevent this.

II. MINUTES

The minutes of the meeting held at the Culloden Hotel, Craigavad, Northern Ireland on Saturday, 15th June 1985 were confirmed and duly signed.

III LAWS OF THE GAME AND INTERNATIONAL BOARD DECISIONS

Proposals and amendments submitted under Rule 3

- (1) Proposed by The Fédération Internationale de Football Association:

Law VIII – The Start of Play

Present Text

(d) After any other temporary suspension; when restarting the game after a temporary suspension of play from any cause not mentioned elsewhere in these Laws, provided that immediately prior to the suspension the ball has not passed over the touch or goal-lines, the Referee shall drop the ball at the place where it was when play was suspended and it shall be deemed in play when it has touched the ground; if, however, it goes over the touch or goal-lines after it has been dropped by the Referee, but before it is touched by a player, the Referee shall again drop it. A player shall not play the ball until it has touched the ground. If this section of the Laws is not complied with the Referee shall again drop the ball.

Proposed New Text

(d) After any other temporary suspension; when restarting the game after a temporary suspension of play from any cause not mentioned elsewhere in these Laws, provided that immediately prior to the suspension the ball has not passed over the touch or goal-lines, the Referee shall drop the ball at the place where it was when play was suspended, *unless this occurs within the goal area, in which case it shall be dropped on the six yard goal area line, perpendicular to where it was situated when the game was suspended.* It shall be deemed in play when it has touched the ground; if, however, it goes over the touch or goal-lines after it has been dropped by the Referee, but before it is touched by a player, the Referee shall again drop it. A player shall not play the ball until it has touched the ground. If this section of the Laws is not complied with the Referee shall again drop the ball.

Reason:

In order to avoid players crowding and hence jostling when a ball is dropped on the goal-line between the goal-posts, the ball shall be dropped on the six yard goal area line, which is parallel to the goal-line and forms one of the sides of the rectangle being the goal area.

III LAWS OF THE GAME AND DECISIONS OF THE INTERNATIONAL BOARD

Proposals and amendments submitted under Rule 3

(1) Proposed by the Fédération Internationale de Football Association

Law III – Number of Players

Present text

- (5) When a goalkeeper or any other player is to be replaced by a substitute, the following conditions shall be observed:
- (a) the Referee shall be informed of the proposed substitution, before it is made;
 - (b) the substitute shall not enter the field of play until the player he is replacing has left, and then only after having received a signal from the Referee;
 - (c) he shall enter the field during a stoppage in the game, and at the half-way line;
 - (d) a player who has been replaced shall not take any further part in the game;
 - (e) a substitute shall be subject to the authority and jurisdiction of the Referee whether called upon to play or not.

Proposed new text

- (5) When a goalkeeper or any other player is to be replaced by a substitute, the following conditions shall be observed:
- (a) the Referee shall be informed of the proposed substitution, before it is made;
 - (b) the substitute shall not enter the field of play until the player he is replacing has left, and then only after having received a signal from the Referee;
 - (c) he shall enter the field during a stoppage in the game, and at the half-way line;
 - (d) a player who has been replaced shall not take any further part in the game;
 - (e) a substitute shall be subject to the authority and jurisdiction of the Referee whether called upon to play or not.
 - (f) **a player who is being replaced ceases to be a player and the substitute becomes a player from the moment the game is restarted.**

Reason:

There appears to be some confusion as to whether a substitution is completed at the moment the player being substituted leaves the field of play, or when the substitute actually enters the field of play, or when the ball becomes next in play. The proposed new text is to clarify this situation.

Amendment submitted by

Decision

The Scottish Football Association

- (5) When a goalkeeper or any other player is to be replaced by a substitute, the following conditions shall be observed:
- (a) the Referee shall be informed of the proposed substitution, before it is made;
 - (b) the substitute shall not enter the field of play until the player he is replacing has left, and then only after having received a signal from the Referee;
 - (c) he shall enter the field during a stoppage in the game, and at the half-way line;
 - (d) a player who has been replaced shall not take any further part in the game;
 - (e) a substitute shall be subject to the authority and jurisdiction of the Referee whether called upon to play or not.
 - (f) **the substitution is completed when the substitute enters the field of play, from which moment he becomes a player and the player whom he is replacing ceases to be a player.**

The proposal of the Federation is withdrawn in favour of the amendment of the Scottish Football Association.

The amendment submitted by the Scottish Football Association was adopted.

(2) **Proposed by the Football Association**

Law XI – Off-Side

Present text

- (3) A player shall not be declared off-side by the Referee
- (a) merely because of his being in an off-side position, or
 - (b) if he receives the ball, direct from a goal-kick, a corner-kick, a throw-in, or when it has been dropped by the Referee.

Proposed new text

- (3) A player shall not be declared off-side by the Referee
- (a) merely because of his being in an off-side position, or
 - (b) if he receives the ball, direct from a goal-kick, a corner-kick, a throw-in, **a free-kick**, or when it has been dropped by the Referee.

Reason:

Free kicks result from fouls or misconduct offences. The alteration in the law will assist further the non-offending team and also generate more action near goal, with resulting greater excitement for players and spectators.

Amendment submitted by

Decision

The proposal of the Football Association was not adopted.

(3) **Proposed by the Fédération Internationale de Football Association**

Law XIV – Penalty-Kick

Present text

A penalty-kick shall be taken from the penalty-mark and, when it is being taken, all players with the exception of the player taking the kick, and the opposing goalkeeper, shall be within the field of play but outside the penalty-area, and at least 10 yards from the penalty-mark. (...)

Proposed new text

A penalty-kick shall be taken from the penalty-mark and, when it is being taken, all players with the exception of the player taking the kick, **properly identified**, and the opposing goalkeeper, shall be within the field of play but outside the penalty-area, and at least 10 yards from the penalty-mark. (...)

Reason:

If the player who is about to take a penalty-kick is properly identified, i.e. is recognizable both to the referee and the goalkeeper, it will prevent any other player from his team from taking the kick instead of him, as has been the case when a player has taken the kick from some distance, leaving the penalty-area and the arc of the circle to do so.

Amendment submitted by

Decision

The proposal of the Fédération Internationale de Football Association was adopted.

IV ITEMS FOR DISCUSSION

(1) Submitted by the Fédération Internationale de Football Association

Law III – Number of Players, item (3) of the decisions of the International Football Association Board

The possibility of all the other players, who do not form part of the eleven fielded players, being selected as substitutes (within the framework of a FIFA competition, for which it is requested at the start of the same to enter more than 16 players), will be discussed by the FIFA Referees' Committee which, if the case may be, will submit a concrete proposal to this effect to the 1987 International F.A. Board annual meeting.

(2) Submitted by the Football Association

Law XII – Fouls and Misconduct, item (5) of the Law

The Board is of the opinion that, for the present time, the Law is clear and does not require further explanation or amendment.

(3) Submitted by the Fédération Internationale de Football Association

Law XIV – Penalty-Kick

FIFA will present a concrete proposal to the 1987 International F.A. Board regarding the standardised wording of this Law.

(4) Submitted by the Football Association

Law XV – Throw-in

The Football Association will present a concrete proposal concerning the amendment of this Law to the 1987 International F.A. Board annual meeting.

(5) Submitted by the Football Association

Taking of kicks from the Penalty-Mark (Knock-out Competitions – Obtaining a Result)

The International F.A. Board thinks that it is not necessary at the present time to alter or amend the procedure regarding the taking of kicks from the penalty-mark to decide the winner.

V. 1987 Meeting of the International Football Association Board

The 1987 meeting of the International F.A. Board will take place on 13 June, 1987 in Wales.

VI. Other Business

There were no comments under this item.

Dr. Havelange thanked the members for their efficient work and invited them to attend the celebrations of the 100th Anniversary of the first International F.A. Board meeting and the official banquet both to take place that evening. He then closed the meeting.

Mr. Millichip thanked the FIFA for its warm hospitality and congratulated the FIFA President for the efficient manner in which he had chaired the meeting. He concluded by expressing the wish that the 1986 World Cup would prove a great success.
